In line with the NDIS principle of choice and control, Home in Place offers a wide range of housing options for people with a disability. Our focus is providing modern, accessible, purpose-built homes that are close to services, transport and support. Homes where residents can live as independently as possible and engage in their communities.

Lately there has been some discussion about **group homes** being a singularly bad thing.

The reality is that for some people they are an ideal alternative for people currently living in the family home or institutions, especially for those with limited SDA funding. Some residents thrive on the connection to others that a group home provides. Most of our group homes are new and purpose built. Group homes aren't for everyone but neither are single occupancy villas or apartments.

The other concerning issue on my mind of late is **NIMBYISM**. Many of our newsletter readers will know what I am talking about. Disability housing – not in my backyard. Shockingly, my team deal with complaining neighbours who say things like "Why do they have to live here – why don't they go back to where they come from?". While we respectfully investigate and respond to all complaints, some are based on ignorance and discrimination.

While most of our neighbours and society more broadly is supportive of people with a disability living independently in our community, some attitudes need to change. We have started a conversation on Facebook and LinkedIn on this issue to raise awareness that NIMBYISM is not OK. Please feel free to share to help change attitudes. Janis has recently moved into one of our new, purpose-built SDA homes in the Newcastle suburb of Wallsend. She had been living in older style group home for more than 20 years.

As Janis is over 65, she is not eligible for the NDIS. But through the Home and Living Assessment Process she is still able to access SDA housing. There are pathways, other than the NDIS, to gain access to appropriate disability housing.

Our SDA Relations Officer Sarah caught up with Janis and her niece Tammie on a visit to see how Janis is settling in. Tammie says Janis seems so much happier and content. She loves having her own space and has made the unit her own. Janis received Supported Independent Living (SIL) support from Cerebral Palsy Alliance in her new forever home.

This new, purpose built, three resident home is for people requiring high physical support accommodation and is ready to move into now.

The single storey home boasts four large bedrooms, two bathrooms, two parking spaces, a spacious shared open plan lounge room and kitchen, shared laundry, wide hallways, an outdoor alfresco area and quality inclusions throughout. Residents are only 15 minutes from the Ipswich CBD.

Home in Place has a range of SDA properties in different SDA categories - from 5-bedroom group homes to custom-built individual homes. We have vacancies in NSW, QLD and VIC.

South Australia – we're coming



Home in Place is planning to start up in South Australia by the end of this financial year.

We're keen to hear from people needing SDA housing and their families, SIL and other support providers trades, as well as property owners, developers and investors, so that we can work together to bring more choice and control in disability housing to South Australians.
