Linda and her daughters Emma and Sophie are living happily together in a purpose-built SDA home in Redlands, Queensland. While always grateful for having a roof over their heads, the family was living in social housing that wasn't designed for Sophie and Emma's disabilities and support needs. After Emma and Sophie got SDA in their NDIS plans, it took Linda several years to find a suitable SDA home.

Most providers would not allow Linda to live with her daughters and homes were unable to accommodate the family dogs. Then she found Home in Place who had a suitable SDA property with an owner who was more than happy for Linda and the family pets to live with her daughters. Our team had kept in touch with Linda for more than two and a half years before we were able to help secure their forever home.

Our Tenant Relations Officer Katrina dropped off one of our Christmas hampers for the family to enjoy during a recent property inspection.

The home is in a quiet area but close to facilities, transport, shopping and the beautiful lake foreshore. There's two living quarters. One with 3 bedrooms, a lounge and kitchen. The other has 2 bedrooms and a lounge. The spacious main bathroom has a hoist and Arjo bath.

The vacant large bedroom has a built-in wardrobe and provision for a ceiling hoist.

Onsite overnight assistance is available.

The seven-unit complex has options to live solo or with other people, plus flexible SDA funding eligibility. You can use your own support providers or the onsite Supported Independent Living (SIL) provider - Aruma.







The easy access homes are in a quiet cul-de-sac with a park at the end of the street. Each home boasts oversized ensuite bedrooms, sunny courtyards and quality finishings, as well as easy access to transport, hospital, and shops.

## New report on supply of SDA housing

The latest edition of the <u>Specialist Disability Accommodation (SDA) Supply in Australia report</u> has been released by Housing Hub and Summer Foundation. The report integrates the findings of a survey of 60 SDA providers with NDIA data on enrolled SDA to offer vital supply data to the market.

#### Key findings

- 2,287 SDA places were being developed across 1,543 SDA dwellings
- 60.7% of the reported SDA places were being developed by private housing providers
- Western Australia had the greatest amount of SDA places in development (28.0%) followed by Victoria (20.4%), NSW (23.0%), and Queensland (16.2%).
- Most SDA places were being developed in apartments (37.7%), houses (33.1%), and villas/duplexes/townhouses (23.6%). Only 5.6% of places were in group homes.
- More than two-thirds (68.4%) of pipeline dwellings were for one resident.
- Most places were being developed for High Physical Support (71.5%), followed by Robust (11.6%), Improved Liveability (9.1%) and Fully Accessible (4.8%)
- 67.6% of providers gave tenants full choice over their support provider, with only 13.5% limiting their tenants to receive housing and support services from the same organisation.

## Awards recognise our team's skills and dedication

Two of our team members have been recognised for their skills and dedication to their role of providing people with quality specialist disability housing. Well done, team!

Our Program Co-ordinator for our Home4Life homes, **Alex**, was Highly Commended in the Rising Star category of the national 2023 Power Housing Awards.

NSW Fee for Service Program Coordinator, **Dinah**, was recently recognised in Home in Place's staff recognition awards.

### Final Report of Review of the NDIS released

The <u>Final Report of the Independent Review of the National Disability Insurance Scheme (NDIS)</u> has been released. The fact sheet on the review panel's recommendations on housing and living supports is <u>here</u>.

#### The recommended reforms for SDA

- SDA categories and design standards should be reviewed to ensure they meet needs, remove the "Improved Liveability" category and create a new "Shared Living Support" category.
- SDA and living supports should be from separate providers.
- State and territory governments should agree to upgrade or repurpose ageing SDA accommodation and transition participants to housing in line with their needs and preferences. The NDIA should change its policies to reduce the bedroom count of ageing SDA dwellings.

The report makes 26 recommendations which include 139 detailed actions, some of which go beyond the NDIS. The independent review panel has designed the recommendations and actions to work together and says they must be considered as a total package of reforms.

#### The team hits the road









Tenant relations officers **Sommer** and **Emma** wer e recently on the road in parts of NSW. They travelled a combined 1,300km to complete 12 property inspections in the Central West and Northern Rivers. Sommer reported that the residents were all very happy and were excited to show her their rooms. She can't wait for the next road trip. Emma was delighted that the tenants remembered her from her last visit and said it was great to see them again.

Meanwhile, our newest team member **Nick** was on the road between Newcastle, Sydney and Albury – including paying a visit to meet residents at our featured home at Lake Albert (above) where we have a vacancy.

# AIHW dashboard on younger people with disability in aged care

The Australian Institute of Health and Welfare (AIHW) publishes a <u>quarterly dashboard</u> of progress to meet the Australian Government's targets to reduce the number of younger people with disabilities going into residential aged care and assist those in aged care to move into more appropriate housing.

The most recent data shows that, despite good progress over the past 12 months, the 2022 targets were not met. The government is still not on track to meet its 2025 target of no people under the age of 65 with a disability living in residential aged care.

#### **Key findings**

- In the three months to June 2023, 72 people aged under 65 were admitted into permanent aged carea 29.4% decrease from the same period in 2022.
- At 30 June 2023 there were 38 people aged under 45 living in permanent aged care a 44.1% decrease from 2022.
- At 30 June 2023 there were 2,067 people aged under 65 living in permanent aged care a 29.6% decrease from 2022.
