We empower children and young people by listening to their voices and considering their needs in our practices, decisions, and policies.

Values Underpinning Our Commitment

Protecting children from harm is our highest priority. We ensure that our environments—whether physical, virtual, or service-related—are safe, inclusive, and supportive.

We are committed to ensuring the cultural safety of all children and young people, including First Nations children and children from culturally and linguistically diverse backgrounds. We also prioritise the safety of children with disabilities.

Every child's right to be protected, respected, and empowered is central to our operations.

How We Demonstrate Our Commitment

Home in Place recruit staff and volunteers who demonstrate child-safe values, and all personnel undergo background checks. Our staff are trained in child protection, ensuring they are well-equipped to maintain safe environments.

We take a proactive stance on child safety by fostering a culture that empowers children to speak up and participate in decisions that affect their lives.

We have accessible and confidential reporting systems in place for children, families, staff, and volunteers to report any safety concerns. All reports are handled with sensitivity and forwarded to the appropriate authorities as required by law.

Our Child Safe Policies and Procedures are reviewed frequently to ensure they remain relevant, effective, and aligned with the latest legal requirements and best practices.
